

#### How likely am I to graduate and how long will it take?


- XX% of students graduate in 4-years

#### Will I be able to repay my student loans after I graduate?

#### **Student Loan Debt**

The average amount of loans students borrow to get a degree as compared to other institutions. The Administration is seeking ways to provide this information to students and families.

#### **Earnings Potential**

The President has proposed providing this information to students and families.

### **Calculating Net-Price**

Who is included in the calculations?

First-Time Full-Time Degree Seeking Undergraduates (FFDSU) receiving grant or scholarship aid from either the Institution, Local, State, or Federal Government (lets call these sources Group A)

## **How is Net-Price calculated?**

### Net-Price = Cost of Annual Attendance

Average Total Grant or Scholarship Aid from Group A received by FFDSU students

### **How is Cost of Attendance calculated?**

#### **Cost of Attendance**

Tuition + Fees + Books + Weighted Average of Living Arrangements\*

Sample Calculation :

Cost of Attendance (2010-11)

34,872.00 + 350.00 + 1500.00 + 12,693.00 = 49,415.00

## **Limitations of Net-Price**

#### What is Net-Price not taking into consideration?

- the proportion of students receiving aid at the institution
- the type of aid a student is likely to receive at the institution



### Colleges can differ greatly on the proportion of students receiving aid but still have the same Net-Price

	<u>College A, N=232</u>	<u>College B, N=232</u>
Total Grant/Scholarship Aid:	\$3,377,229	\$322,449
# FFDSU Receiving Aid:	199	19
% FFDSU Receiving Aid	86%	8%
Average Grant/Scholarship Aid:	(\$3,377,229/199) = <mark>\$16,971</mark>	(\$322,449/19) = \$16,971

If School A and B's Cost of Attendance is the same, then School A and B will have the same Net-Price:


### Why is the type of grant aid a student receives important?

Net-Price gives an estimate of how much a student will pay in college costs in the first year, if he/she **is eligible** for grant/scholarship aid from the federal, state, or local government or the institution.



## **Limitation of Net-Price**

# What else is not taken into consideration, when looking at net-price?

• How many years it may take a student to graduate from the college **or the likelihood of conferring a degree from the college.** 

### The Majority of schools on the Highest Net-Price List also have higher graduation rates



"We want to arm students and parents with the information they need to make smart educational choices...Students need to know up front how much college will actually cost them instead of waiting to find out when the first student loan bill arrives. # Limitations for Accountability • Simulated Strategies for Lowering Net-Price

### How can a college reduce its Net-Price?

Net-Price = Cost of Annual Attendance

Average Total Grant or Scholarship Aid from Group A received by FFDSU Students

- We can lower the Cost of Attendance
  - Lower Tuition,
  - Lower Fees
  - Lower Living Arrangement Costs
- We can change the Average amount of grant/scholarship aid awarded to students (i.e. we can change the way institutional aid is awarded)

-

- Decrease the number of students receiving institutional aid
- Increase the institutional aid budget, hold percentage of students receiving aid steady
- Hold the institutional aid budget steady, decrease the number of students receiving aid
- Increase the institutional aid budget, decrease the percentage of students receiving aid

#### Changes to the amount and distribution of institutional aid awards affect Net-Price and college rank on the Net-Price list

## **Recommendations:**

- Put a Filter on Net-Price: by income
- Focus students towards using the Net-Price Calculator
- Counterbalance Average Net-Price by including % of students receiving grant aid by income bracket (incorporate this into score)
- Determine an ROI based on individual student data
