TREASURER'S REPORT

Bettina handed out Income and Expense reports from Conferences and CAIR Budget (2 pages)

Bettina handout out segmental report on summary. CSU steady or up. UC and CCC down, Independents up.

Suggestion: Have CAIR event this Spring before budget cuts: Might work.

SITE FOR 2009 Conference

Room Nights:

--Should we restructure conference to have 1 day conference instead of 2 in light of budget cuts? No!

--Workshops: Cut them

-- CCC impact: Bad cuts – RP group

DECISION: Choose Doubletree, Sacramento – Negotiate Internet access charge.. Negotiate 75%-80% pickup. Busses are \$125 per hour per bus, 30-35 people....Doubletree to be 17th to 20th. Instead of 18th to 20th.

Vote for Sacramento: 8-0-1 (David R.) – go to Doubletree.

PROBLEMS WITH THE PRESIDENCY

Bill wants to help but has serious health issues. Intentions are good but may not be able to follow through.

CAIR Constitution:

CRAIG: BOARD MOVES TO ACCEPT, IN ABSENTIA, THE RESIGNATION OF BILL ARMSTRONG AS VICE-PRESIDENT OF CAIR.

Discussion: Is Bill resigning as Vice-President or as President>

MODIFICATION OF RESOLOUTION: Accept resignation from office (not specific)

JANEL: BOARD MOVES TO ACCEPT, IN ABSENTIA, THE RESIGNATION OF BILL ARMSTRONG AS VICE PRESIDENT FROM THE BOARD OF CAIR.

VOTE: Unanimously passed 9-0

PRESIDENCY:

Bettina: Have special election, move that Sam be nominated to run for President.

Constitutional Issue: Sutee succeeds to Presidency

Secretary: Would need to be elected.

In constitutional amendment:

Special election, would be held by David.

Sutee declined to accept Presidency in order to preserve the order of succession and to have the opportunity to become President in Sacramento.

Bettina: Have special election, move that Sam be nominated to run for President.

BETTINA: Move special election for President to preserve the current order of succession by segment.

Approved: 9-0 (unanimous)

Cel: Call for Nominations from UC for special election. Experience planning conferences.

Cel to send letter to Bill and deadline for nominations on January 28th.
