History of CCC Accountability

- u Simple reporting, fact books until 1998
- u 1998: State provides \$300m ongoing in exchange for accountability reporting
 - "Partnership for Excellence" was born
 - u CCC developed report in isolation
 - u CCC allowed to determine "adequate progress"
 - u "Contingent funding" never triggered
 - Used 5 metrics to measure system and collegelevel performance

History of CCC Accountability

- u AB1417 passed (2005-06) creating framework report for CCC accountability reporting
- "ARCC" (Accountability Reporting for the Community Colleges)
- u Took one year to develop metrics, now in third reporting cycle

ARCC as a Template

- u ARCC is mandatory, not voluntary
- All data used come from System Office MIS, existing submissions
- u Reporting done at system level or by college, not broken down further
 - But unitary datasets used in creation are available
- u 850+ page document

ARCC

- u The Model:
 - Measures 4 areas with 13 metrics:
 - Student Progress & Achievement-Degree/Certificate/Transfer
 - Use Student Progress & Achievement-Vocational/Occupational/Workforce Dev.
 - u Pre-collegiate improvement/basic skills/ESL
 - u Participation
 - "Process" is not measured.

Major Advancements of ARCC

- u Creating a hybrid grad/transfer rate.
- u Finding transfers to private/out of state institutions.
- u Doing a wage study.
- u Creating peer groups.
- Local qualitative response/assessments (500 words).

IPEDS as a Template

- u Grad Rate Survey (and others): completed on behalf of institutions by System Office
- u IPEDS-GRS has long been a poor accountability instrument for measuring institutional performance

IPEDS-GRS-2

- u Counts first-time, full-time, degreeseeking students starting in fall (3%)
- u Tracks only 3 years
- u Counts awards before transfers
- u Counts lateral transfer as transfer

Fixing This: HEOA Reauth.

u "...convene a group of representatives...to develop recommendations regarding the accurate calculation and reporting of...(IPEDS-GRS-2) by two-year, degreegranting institutions...shall consider the mission and role of two-year degree-granting institutions...and may recommend additional or alternative measures of student success...in light of the mission and role of such institutions."

Voluntary System: CSRDE

- u CSRDE: Consortium for Student Retention Data Exchange
- Voluntary data submission (not unitary data)
- u A superset of IPEDS-GRS data
 - Bigger cohorts, longer track period
- Annual peer reports, comparisons

CSRDE

- u CSRDE now expanding into CC market
- u CCC system invited to join, influence metrics, and help govern board
- u CCC System Office joining CSRDE on behalf of all 100 campuses in 2009
 - I CCCCO will submit all data
 - CCC campuses will get peer reports
 - CSRDE also sponsors monthly webinars

CSRDE Report

- By institution, separated by size, and ethnicity
- Focused on retention, persistence, graduation, transfer rates
- u All rates cut by year lengths (1,2,3,4,5,6 yrs)

CCC VSA Development

- u Recently, ACCT, AACC and College Board announced start of a yearlong process of developing VSA for CC's
- Standard metrics suggested: course completion, transfer readiness, employer satisfaction
- u Designed to build body of evidence in support of CC budgets nationally
